SUPERVISOR COMMENTS

Officers investigated a juvenile abuse after a CPS cross report of the mother hitting her child with a belt. It was determined to be a form of discipline, however was a little excessive.

The report will be forwarded to the DA for review. Officers responded to a rollover accident with injury. A 15-year-old with a learner's permit was driving without a licensed driver and was the cause of the collision. The other driver was transported to the hospital after her vehicle turned over on it's side and was unable to get out. Officers also responded to a weapon offense. The RP said she was being followed by a male who had a gun. Officers located a vehicle matching the suspect's vehicle description and detained the driver. The victim was able to identify him but no gun was found in the vehicle and no report of brandishing was made Due to no crime being determined the male was released from detention.
