***1. AMENDMENT TO PLANNED DEVELOPMENT 190 (LANDER CROSSINGS)**

Planned Development 190 is an approved commercial development, consisting of a 3-story hotel, four retail buildings and associated on-site improvements. The applicant has proposed an amendment to the phasing schedule for this Planned Development in order to allow site improvements to only a portion of this commercial center during Phase I of construction. The partial site improvements would accommodate development of an 85-unit hotel, which would also become part of Phase I if this amendment is approved. Phase 2 would consist of the remaining site improvements and building construction for this project. The subject site is 1851 Lander Avenue (Stanislaus County Assessor's Parcel Number 044-064-015-000) This amendment is Exempt from the California Environmental Quality Act (CEQA) in accordance with CEQA Section 15305, "Minor Alterations in Land Use Limitations." There is a \$125.00 filing fee for the Appeal Application. If an Appeal Application is filed, a Public Hearing will be scheduled by the City Council to consider the appeal.

-- APPLICANT REQUESTS--
EFFECTIVE NOVEMBER 27, 1989**

An applicant may request the continuance of a pending application or scheduled matter set for consideration by the Planning Commission by filing a request for a continuance not less than three (3) hours prior to the scheduled consideration of the application pursuant to City Council Resolution No. 89-248. The request must be written and filed with the City of Turlock Planning Division. There is a \$305.00 Filing Fee Deposit for the Continuance Request Application. **The granting of a request for a continuance of a pending application is discretionary on the part of the City of Turlock.
