# 1. DEVELOPMENT AGREEMENT FOR THE EVERGREEN MARKET

Director of Development Services Katie Quintero stated a green sheet for this item was handed out requesting a continuance to the December 1, 2022 Planning Commission meeting for the proposed Development Agreement between the City of Turlock and Evergreen Market for a cannabis retail dispensary at 101 E. Glenwood Avenue due to the applicant requesting and staff supporting, additional time to address language in the Development Agreement.

## **Public Hearing**

Chairman Davis opened the floor for public participation.

Arianna, attorney for the applicant, stated they are requesting to continue the development agreement to the next meeting to clarify the language in the agreement.

Ron Bridegroom, stated the original development agreement was granted in 2019 but was never signed which adds up to a \$600,060 loss of revenue. The RFQ and DA promised 5 ½ would be donated to fund nonprofits and homelessness in the City of Turlock. He stated the City's justification for the cannabis pilot program was the need for funds which we have not collected. Mr. Bridegroom also stated had concern with the traffic and safety this dispensary will cause in this area.

Able Dias, stated he is opposed to this project at this location as it will bring more traffic and homeless in this area.

DJ Fransen, stated he was opposed to this development agreement as the original had not been tracked or signed and needs to be reviewed by the City Council first. Mr. Fransen also asked if the whole process should start over again as there is a 5-year time line for the development agreements.

Chairman Davis closed the floor for public participation.
